WIAPS APPROVED GROUNDWORKER (EXTERNAL SERVICES) APPLICATION



This application is to become a member of the Water Industry Approved Plumbers' Scheme (WIAPS). Membership is open to qualified groundworkers and the businesses that employ them ('Approved Sector Worker Business').

The scope of work which an approved Water Supply Pipe Installer can issue certificates of compliance for includes work on installing, repairing or maintaining the supply pipe (the underground pipe).

It is limited to work on the pipe supplying premises from the external stop tap up to the point of entry of the pipe above floor level in a premises where an internal stop valve is normally installed. The work includes the installation of the internal stop tap (in any premises) and whole site protection on non-domestic premises.

An annual fee will be introduced from 1st April 2024 for any business that has sector members. Sector members include: external services installers, sometimes called Water Supply Pipe Installers or groundworkers, Catering installers, Point of use installers and RPZ valve testers. The fee will be the same for all businesses, regardless of the number of approved individuals.
